4-H ENROLLMENTS

This is your last call to get your 4-H on-line enrollment updated for 2025 and remember, volunteers need to update their profiles, too! <u>This will be the last month that we will send out the newsletter if you have not re-enrolled by January 31</u>. You are now able to add projects or delete them from your list of enrollments until May 1 for all areas, except Livestock projects, which need to be enrolled in prior to the weigh-in/tagging and identification date set for each project species.

CLUB LEADERS— It is very important that you set up a Volunteer Profile in 4-H Online and verify that you have completed the volunteer training in 4-H Online! This helps us manage volunteer resources, training, and certification. Please remember that in order for a 4-H Club to be in good standing, you must have TWO leaders who have current 4-H volunteer certification. **Be checking your email for links. These need to be completed by February 1st.**

LIVESTOCK WEIGH-IN/TAGGING DATES

If you are planning on showing livestock this year at the County Fair, you MUST weigh and tag your livestock at the respective species weigh-in/tagging dates. Beef weigh-in/tagging has been set for February 13 at Winter Livestock between 4:00 -6:00 pm. Bad Weather date is February 20. Please note the corrected times from previous newsletter!

Fair Checks and Thank You Notes

A reminder we still have a few exhibitors who have not turned in thank you notes for County Fair ribbon premiums. Please do so as soon as possible. If checks are not picked up and cashed by February 1, premiums will be forfeited and returned to the Fair Association.

CITIZENSHIP IN ACTION

Would you like to have more influence in laws and rules that affect your life? Then you'll want to go to Kansas 4-H Citizenship in Action! This two day event is sponsored by the State 4-H Youth Leadership Council. The purpose of the event is for Kansas youth to learn how the state legislative process works and how their voice and participation in decision-making can make a difference in their local communities. The legislative visit will not only familiarize youth with the capitol building, but will also show them how they can affect the legislative process.

This will take place February 16-17, 2025 in Topeka KS - Hotel Topeka at City Center (formerly Capitol Plaza). Youth 13-18 years old by January 1 of the current year are able to participate. Registration will be coming soon and the deadline will be January 24.. Let Andrea or Ethel know if you are interested.

STATE 4-H SCHOLARSHIPS DUE IN EARLY 2025

The Kansas 4-H 2025-26 scholarship application is open. The new scholarship process has combined the State 4-H Scholarships and the Vanier Family Scholarship Program (VFSP) applications together. We hope that this encourages more applicants to pursue both of these scholarship opportunities. All applications and corresponding requested materials must be submitted by **March 1st, 2025**. JUNIOR PRODUCER DAYS REGISTRATION OPEN

The 2025 Kansas Junior Producer Day dates have been set! Junior Swine Producer Day will be Saturday, March 1, with Junior Meat Goat Producer Day scheduled for Saturday, March 22. Both events will be hosted at the Stanley Stout Center, north of the K-State campus in Manhattan.

These events are one-day educational events for families to learn more about the selection and management of a specific specie. Youth, adults, extension agents, project leaders, and volunteers of all ages and skill levels are invited to attend! Presentations will be provided by K-State faculty, staff, students, extension agents, former exhibitors, and guest speakers. Topics range from selection, to nutrition, reproduction, health, clipping and grooming, and showmanship. This is a family learning event! Everyone who plans to attend must register, including both youth and adults. The cost is \$20/person by the deadline, or \$25 after the deadline for both events. Only those who register by the appropriate deadline will receive a t-shirt.

Junior Swine Producer Day registrations are due February 5, with Junior Meat Goat being due February 26. Registration is open now and can be completed online using this link: http://bit.ly/ksuasiregister. Junior Producer Day event registrations are non-refundable.

An optional YQCA instructor-led training and state livestock nomination session will be offered. Specific details about the YQCA certification will be shared with those who indicate on their registration that they plan to stay for the additional class. The K-State Sheep & Meat Goat Center is also offering an opportunity to tour their facility the night before the Junior Meat Goat Producer Day program, or following the event on March 22. Additionally, any high school student who would like to participate in a campus visit on the Friday prior either junior day is asked to indicate that on their registration.

LEADERS and CLUB CORNER.....

We will no longer hold a separate Community Leader meeting prior to 4-H Council. Everything will be incorporated into the council meeting or sent separately to community leaders by email.

A reminder all leaders (Community Leaders, parent drivers to events, exchange hosting parents, etc) need to complete leader process through 4-H Online. You will need to complete the KS 4-H Volunteer Orientation after the offices approval. Then if you are needing to update your criminal background check (only good for 3 years) an email from Andrea with a link will be sent to you to complete the request. This is for your protection as well as for our youth.

If your club has <u>not submitted the required Financial review which was due November 1</u>, it must be turned in to the office by February 1 or you run the risk of your club's charter being revoked.

A reminder your club officers should be responsible for their duties and these duties should not be completed by Community Club leaders or parents. For example, treasurer should be writing checks, making deposits, etc; secretaries should be writing and reading the minutes (may have parents assistance, but completed primarily by the club youth officer); club members making decisions and motions. Our program is an educational organization helping youth learn responsibilities for life. Being an officer has responsibilities with the position and provides many leadership educational opportunities.

4-H Project Guide is available and our Ford County 4-H Family Guide has been updated and posted on our website.

<u>Several Leaders and members need to re-enroll soon through 4-HOnline</u> or else this is the last newsletter you will receive.

Parliamentary Corner...

President should always re-state a motion before it is voted on. This makes sure all members and parents understand what is being voted on. This is especially important if you have youth who do not speak loudly and a noisy background at your meeting location. Members should address the president and stand when called on by the president.

4-H Policy Information

In November we shared information from the Kansas 4-H Policy Handbook and we are continuing this month with information on Financial and fundraising. This it to help our families and volunteers understand policies which govern our state 4-H program. If you have questions, please let us know.

Club Finance

Clubs that manage funds must have a unique IRS Employer Identification Number (EIN), applied for through the local extension office and follow all Kansas 4-H financial policies.

Clubs that handle money are required to keep that money in a financial institution in a checking account and are required to submit a 4-H Club/Group or Other Extension Affiliated Group Annual Financial Report to the extension office each year (suggested deadline is November 1). Clubs are also required to maintain active Charter status in order to have any money in the name of 4-H

Annual Financial Review of 4-H Club Accounts

Kansas Extension law, as well as federal and state expectations for use of all funds generated in support of Extension programs, require the Director of Extension and Extension Council/District Boards to be accountable for all funds generated for Extension programs within their jurisdiction.

In other words, the Director of Extension and the Extension Board are accountable for funds raised and/ or collected by such groups as 4-H Clubs, 4-H Groups, 4-H Councils, Master Gardeners, etc.

In order for the local extension unit to ensure compliance with financial requirements for 4-H Clubs/ Groups and other extension affiliated groups, a yearly financial review of those accounts is to be conducted by a Financial Review Committee. Approval of the reports should be documented by the local unit board recording in their minutes a motion to approve the reports, including in the minutes the name of each

4-H club/group and other extension affiliated groups. This review and board approval are required of all 4-H clubs/groups and other extension affiliated groups.

Approved Volunteers as Signatories on 4-H Club Accounts

Clubs/Groups and other Extension affiliated groups need to have at least two screened, board-approved adult volunteers, no immediate family, as signatories on 4-H Club accounts.

7.5: 4-H Club Financial Management

All accounts and all expenditures of funds of the local extension unit, from whatever source derived, are subject to authorization and approval of the local board and the Director of K-State Research and Extension. The director and local boards are accountable for all funds generated for extension programs. This includes all funds collected/raised in the name of extension 4-H programs including clubs and other extension affiliated groups.

All clubs, project clubs, other affiliated 4-H groups, and the 4-H Council operate according to policies and procedures determined by U.S. Department of Agriculture, Internal Revenue Service, K-State Research and Extension, and the local board. K-State Research and Extension staff are not allowed to be signatories on 4-H group or club account(s).

4-H Club/Group Financial Review

All 4-H clubs/groups or other extension-affiliated accounts must submit an annual accounting report and undergo a financial review by the extension board or district to maintain their tax-exempt status. All local extension affiliated groups, including 4-H clubs/groups, are included in the tax reporting jurisdiction of local boards. The local extension board should approve the review form and note in the minutes the name of the club/group of each approved financial review report. Upon completion of all extension wide clubs, please forward the compiled list of completed club financial reviews to the State 4-H Office.

Volunteers as Signatories on 4-H Club Accounts

Volunteers who serve as signatories on 4-H accounts must update their current contact information in 4-H Online and clearly show their 4-H club account activity to the board as a part of the club annual financial review.

Noncompliance with Financial Review

Clubs/groups not listed in the 4-H departmental database and not undergoing an annual financial review by the local extension board or any other account not in compliance with this principle: will not be considered a formally authorized club/group/affiliate (club charter will be revoked); will not be considered a charitable organization according to the IRS; cannot accept donations as tax-deductible; will be subject to reconsideration of the privilege of using the 4-H name and emblem as decided by the State 4-H Program Leader; will be responsible for registering and reporting as specified by the IRS as a "for-profit" business, subject to all associated tax filing and reporting responsibilities. County/District Extension Boards are responsible for all 4-H accounts.

Sale of Products by 4-H Clubs and Councils

Commercial Enterprises/Sales

Extension entities are not permitted by the Kansas County Extension Council/District Law to engage in commercial enterprises or to give preferred service to any individual, group, or organization. 4-H Project Prospect Sales/4-H Premium Sales provide a preferred service for the respective project enrollees; therefore, 4-H Project Prospect Sales/4-H Premium Sales will be managed by the local fair association, sponsoring organization, or a third, bonded party.

4-H Camp and Other Accounts

4-H camp and other accounts that do not belong to a 4-H club/group are not allowed and should be maintained by local 4-H councils, or in extension council or district accounts.

Fundraising

Fundraising programs using the 4-H Name and Emblem may be carried out for specific educational purposes. Such fundraising programs and use of the 4-H Name and Emblem on or associated with products and services for such purposes must have the approval of the appropriate extension office (local, county, state, or national level).

Critical elements of these regulations and guidelines include:

All moneys received from 4-H fundraising programs, except those necessary to pay reasonable expenses, must be expended to further the 4-H educational programs. 4-H is considered a non-profit entity; funds must not be accumulated or held over in an account without a proper spending plan.

Private support moneys should be: Given and used for priority educational purposes. Accounted for efficiently and fully.

Fundraising groups properly authorized to use the 4-H Name and Emblem are to be held accountable to the 4-H program granting authorization. There must be a definite plan to account for funds raised prior to authorization. Such a plan should be within the policy guidelines of the state for handling funds.

Any use of the 4-H Name and Emblem is forbidden if it exploits the 4-H program, its volunteer leaders, 4-H youth participants, or the USDA, Cooperative Extension, land-grant institutions, or their employees.

The 4-H Name and Emblem shall not be used to imply endorsement of commercial firms, products, or services.

In connection with 4-H fundraising purposes, the following disclaimer statement must be used on products or services offered for sale: "A portion of the sales price of this product or service will be used to promote 4-H educational programs. No endorsement of the product or service by 4-H is implied or intended."

WHO CAN PARTICIPATE IN 4-H CLUB DAYS?

4-H'ers can participate in Club Days as a CLUB and/or an INDIVIDUAL. You must be enrolled through KS 4-H Online. Remember, Cloverbuds cannot participate in this competitive event.

WHAT EVENTS CAN I DO?

There are a variety of events to please everyone. Please see the next page for a brief description of 4-H Club Day events. FULL descriptions and rules can be found on our website.

HOW DO I REGISTER?

EACH 4-H'er participating in an INDIVIDUAL event needs to fill out an event registration online through Sign Up Genius. If a 4-H'er is competing in a CLUB event, the club leader needs to register for a club time through Sign Up Genius. Please list ALL participants names in the comment area.

Registration link will be available on our Extension website after January 3. Registration needs to be completed by January 24.

COUNTY CLUB DAYS ::EVENTS::

Check General Guidelines as several categories you must give the judge a copy of your music, reading, etc.

MODEL MEETING

Model Meeting - club and 1 or 2 adults

This event allows clubs to act out a 'proper business meeting' which 4-H Clubs do each month at their regular 4-H Club Meeting. In this event, clubs must include 5 parliamentary practices found in the 'Club Days Guidelines.' Two additional topics will be drawn at the competition and must be included during the competition. Please contact the office for more information. 35 minutes maximum

•Gavel Games - 4-6 members

This is a great way for youth to practice parliamentary procedure in a fun atmosphere.

Please see the 'Club Days Guidelines' for complete rules and information. 20 minutes maximum

DRAMATICS:

- One Act Play group—30 minutes maximum
 This is FUN for a club to do! Grab a script and practice, practice, practice! Only one scene set allowed.
- •**Skit** group—10 minutes maximum

 This is also fun for creative minds. Make up your own skit and put costumes and a set to it!
- •Novelty individual or group. 5 minutes max. Are you in gymnastics? Do you like to do ventriloquists acts, stunts, puppets or other forms of entertainment?
- Vocal Performance a solo or group (2 or more)
 5 minutes maximum
 perform a musical piece; sheet music not required for the judges.

DANCE:

- •Folk Step Dance group—10 minutes max.

 May include circle, line, Irish, polka dance etc.
- •Square Dance group— 10 minutes max. Kick-off your shoes for some good ol' fashioned square dancing! 10 min max.
- •Other Dance individual/group, 10 minutes max. Are you in ballet, tap, cheerleading, clogging, etc? Then this is for you!

PUBLIC PRESENTATIONS:

- •Show & Tell 1st or 2nd yr. junior members only This event is as simple as bringing your favorite toy and telling the judge all about it. 5 minutes max.
- Project Talk junior members only
 Gain confidence by talking to a judge about your
 favorite project in 4-H. Visuals are encouraged. 6-7
 minutes max.
- •Public Speaking senior members only
 Take the next step and write your own speech on a
 topic of your choice. 15 min max.
- •Extemporaneous Speaking senior members only Participant draws two topics at competition and chooses one of them to speak on. 15 min prep time. 5 minutes max, 3 minutes minimum
- **Digital Presentation** Put your PowerPoint skills to work! This event can be on a 4-H Project or topic of your choice. 15 minutes—SR; 10 minutes Jr maximum
- •**Demonstration** Show the judge how to make a smoothie, sew on a button, or groom your dog in REAL life! 15 minutes—SR; 10 minutes—Jr maximum
- •Illustrated Talk Readings Show the judge how to do something by using pictures or drawings. 15 minutes Sr; 10 minutes Jr. Maximum
- •Readings—May be a musical, dramatic, interpretive, humorous or other type of reading. 10 minutes or less Readings need not be memorized.
- •CRI—Cover Letter, Resume, Interview Seniors only—15 minutes total, Completed an application; Create a Cover Letter, limit 1 page; Create a Resume, limit 2 pages, submit prior to interview.

Do you have a favorite song from band or vocal in school that you'd love to share for a judge? If so, enter it for Club Days! 4-H'ers must have sheet music for judges. Ensemble has 2-5 4-H'ers
